Prior to starting your special circumstances review, you will be required to complete your 2024-2025 FAFSA application as well as the Verification Process. To complete the verification process, please refer to the list below to determine the documentation required. Please note that all forms listed below require to be signed with handwritten signatures in black ink only. Electronic/typed signatures and signatures made with an electronic pen will hot be accepted.

For Dependent students:

- The 2024-2025 Dependent Standard Verification worksheet
- Submit a signed copy of your 2022 tax return and all 2022 W2s (if applicable). If you are unable to locate your 2022 Tax Return or 2022 W2's, you may request copies of your tax documents by visiting http://www.irs.gov.
- Submit a signed copy of your parents' 2022 tax return and all 2022 W2s (if dependent student). If your parent(s) are unable to locate their 2022 Tax Return or 2022 W2's, they may request copies of their tax documents by visiting http://www.irs.gov.
- If you and/or your parents (if dependent student) did not file a 2022 Tax Return but received income earned from work, you and/or your parents will need to submit the 2024-2025 Non-filing form.
- If your parent(s) would have filed a Foreign Tax Return but were not required to do so, they will need to submit a verification of Non-Filing letter from the foreign tax authority.
 - *Changes to finances due to divorce, death, etc. should be submitted through the Parent or Student Marital Status forms.

For Independent students:

- Submit the 2024-2025 Independent Standard Verification worksheet
- Submit a signed copy of your 2022 tax return and all 2022 W2s (if applicable). If you are unable to locate your 2022 Tax Return or 2022 W2's, you may request copies of your tax documents by visiting http://www.irs.gov.
- If you/or your spouse did not file a 2022 Tax Return but received income earned from work, please submit the 2024-2025 Non-filing form.
- If you/or your spouse would have filed a Foreign Tax Return but were not required to do so, you will need to submit a verification of Non-Filing letter from the foreign tax authority.
 - *Changes to finances due to divorce, death, etc. should be submitted through the Student Marital Status forms.

Please note: The Office of Financial Assistance may request additional information or documents based on your circumstance.
